

Nevertheless, with peculiar undulating terrain and limited cultivable land in the region, livestock production, especially Dairying with a collective and cooperative approach, is the definitive, proven, and sustainable solution to provide an assured livelihood to the people in the region.</p>

<p>Livestock production has always been an integral part of rural livelihoods, and the animal husbandry sector is the major source of supplementary income for rural households in Sikkim and adjoining states. The contribution of the livestock sector to the Sikkim State NSDP is around 6% to 7%.</p> <p>As far as the state of Sikkim is concerned, Dairying is a priority sector for the Government and Sikkim is one of the leading states in Cooperative Dairying in the region and among hill states. In Sikkim, the milk production is growing in double digits with the production of about 2.3 Lakh Litre per day and the procurement and processing in the organized Cooperative sector is around 60,000 liter per day, which is one of the highest in the North Eastern Region, while per capita availability of milk is 354 grams per day.</p> <p>We envisage achieving per capita milk availability at par with the national average and growing above, which I strongly feel is possible with the strengthening of the Dairy cooperative ecosystem in the state. To complement the dairy ecosystem and to drive its growth faster, the Government of Sikkim is providing an incentive of Rs. 8/- per liter of milk produced by the dairy farmers under the cooperative system in the state.</p> <p>I am confident that all these efforts will enable us to meet the twin objective of dairy cooperatives to provide a market to dairy farmers and to meet the nutritional requirement of the population at a reasonable cost.</p> <p>I am proud to state that the National slogan “Sahakar Se Samridhi” is the slogan of our state as well. On behalf of the people of Sikkim, I deeply express my gratitude to the Hon’ble Prime Minister of India, Shri Narendra Modi Ji, and the Union Minister of Cooperation Shri Amit Shah Ji for their concern and gesture toward the upliftment of our state.</p> <p>I am sure that NCDFI and its member dairy cooperatives will keep up the tradition of noble service to the dairy farmers of our great country. I convey my best wishes for great success to NCDFI for its various activities and the release of its Coffee Table Book.</p>

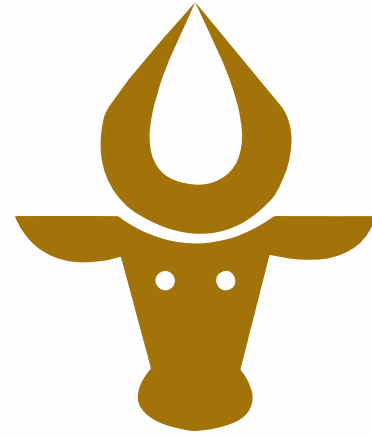

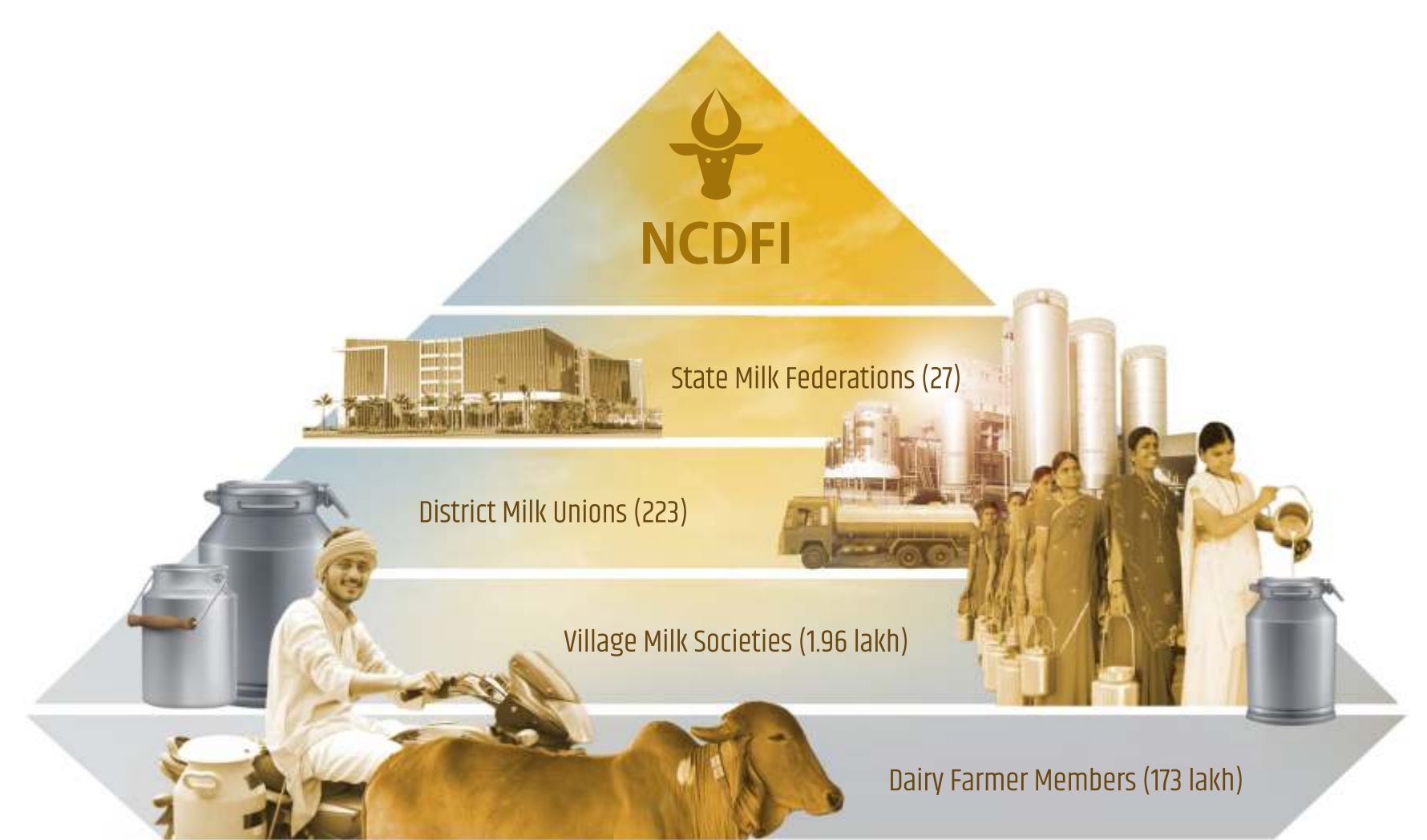

National Cooperative Dairy Federation of India Limited (NCDFI) was established in 1970, just after the launch of the Operation Flood Programme. It is a national-level apex body of dairy/oil cooperatives. Federal dairy/oil cooperatives of states and union territories are its members, and National Dairy Development Board (NDDB) is its Institutional Member. NCDFI left a lasting impression by playing an important role in organising the National Milk Grid during the Operation Flood Programme, along with National Dairy Development Board (NDDB).

NCDFI is primarily involved in coordinating the milk and milk product supplies to defence services under institutional sales; providing an online marketplace for the dairy industry; working for genetic improvement of dairy animals and capacity building through developmental activities. The total business transactions coordinated by NCDFI during 2021-22 stood at ₹ 6,305 crores.

The Adoption of technology and its application to ensure better returns to dairy cooperatives and, in turn to milk producers have been the focus of NCDFI. NCDFI is also inspired by the Digital India Initiative of our Hon'ble Prime Minister Shri Narendra Modi Ji, a flagship programme of the Government of India with a vision to transform India into a digitally empowered society and knowledge economy. Accordingly, with a vision to digitally empower the dairy cooperatives and transform the prevalent trading system, the electronic trading platform 'NCDFI eMarket' is initiated to provide transparent, fair and economic dealings to various dairy cooperatives with the technological partner NCDEX e-Markets Ltd. (NeML), a wholly-owned subsidiary of NCDEX to provide technical support, and with the patronage of National Dairy Development Board (NDDB) on June 10, 2015. Currently, NCDFI eMarket is one of a kind technology platform which is completely devoted to the Indian Dairy Sector, facilitating the bulk trade of commodities and services contracts for dairy sector organisations.

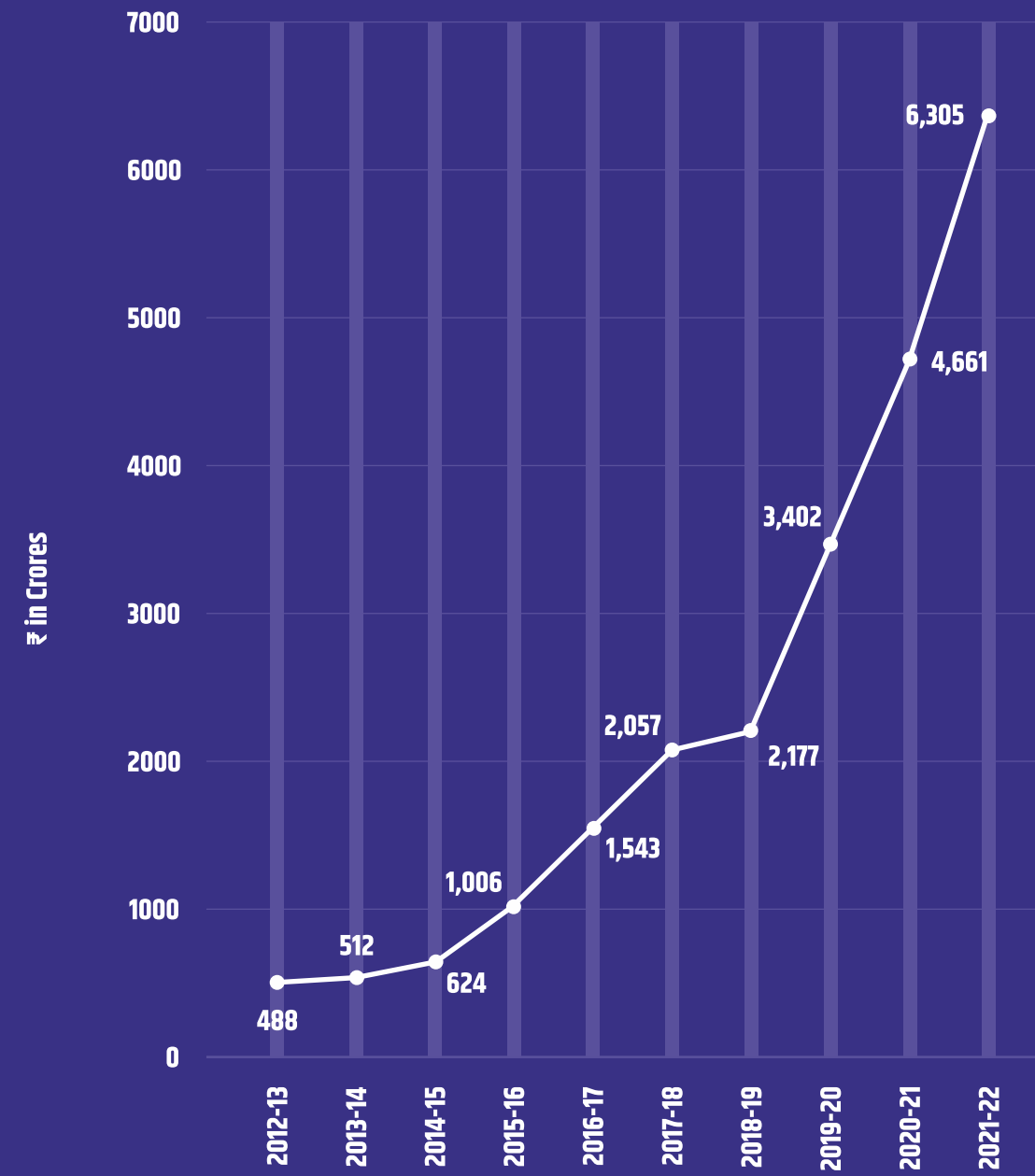

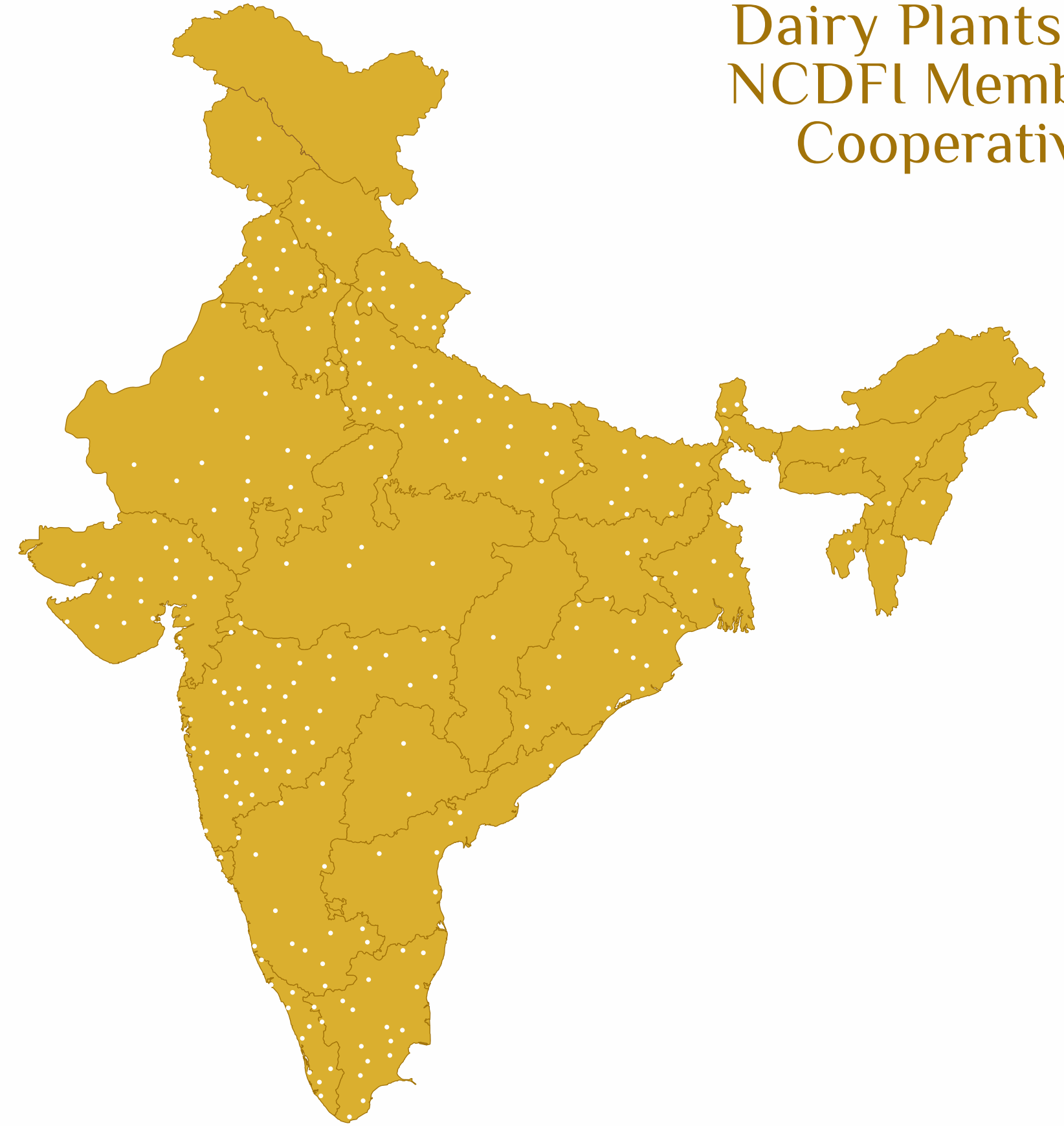
